#### **Addendum Process**

The Standards team is trialling a new process which allows a standard owner to make an amendment without updating the entire content.

The aim is to allow the business the opportunity to take advantage of benefits from a standard change (includes safety, performance and financial benefits) which would normally be too resource intensive, eg older standards. This would work in a similar way to the current Emergency Change process.

10 Facts: Drug and Alcohol Testing









FACT 1: You must not:

- Come to work in an unfit state as a result of consuming alcohol or taking drugs.
- Possess or supply any illegal drug or other drug of abuse at work.
- Consume alcohol or illegal drugs or other drug of abuse at work.

FACT 2: There are different Types of D&A testing.

- Random unannounced testing this is unannounced with no prior notification.
- Pre-placement testing new sponsor testing.
- For cause testing if there are grounds to suspect that individual is unfit through drugs or alcohol.
- Post-incident testing following accidents or serious incidents.

FACT 3: You can be tested anytime you are at work, and this includes attending training courses.

FACT 4: The railway drink driving limits are lower.

England and Wales: 35mg alcohol per 100ml breath.
 Scotland: 22mg alcohol per 100ml breath.
 Network Rail: 13mg alcohol per 100ml breath.





You could be tested for alcohol by the police on the way to work and pass – but fail a D&A test when you arrive at work!


FACT 5: A positive Drugs and Alcohol Test can result in a ban from working on Network Rail Managed Infrastructure for up to 5 years.



**FACT 7:** A positive result can occur if medication (over the counter or prescribed) is not declared when you're being tested for Drugs and Alcohol.

FACT 8: Some drugs can stay in your body for up to 30 days.

**FACT 9:** Even small amounts of alcohol can affect concentration, co-ordination, decision making, muscular control, reaction time, judgement and therefore, your safety and the safety of your workmates, family and friends.

**Brief Description:** 

Checking your Documentation and being Prepared

On some occasions Possession Support Staff are accepting their paperwork (packs) but have not thoroughly checked them for any potential issues. Please ensure before you accept the pack that you check and understand all relevant documentation.

#### CHECK YOUR SWP / SITE DOCUMENTATION -Check:

- Pre-Planning of your work activities.
- Your SWP limits match the WON and match the limits in the roster, this includes if protection is full distance or substandard.
- Your rostered start time against the start time on the WON for your limits, you should normally be on site 1 hour prior to possession.
- You possession limits against your diagrams, checking what references you have on site, which way the job is going, where your access is and any open lines remaining open at site.
- What equipment you need to carry out the role, do you have enough?
- Your method of work and which way you will be walking and how far. Look through the pictures provided and get onto google maps to familiarise yourself with your surroundings.
- Your SSOW are you working safeguarded or separated, where are the open lines, identify any routes open to trains, any points that are still being used by trains.
- Your line diagrams / sectional appendix / hazard directory covers your site of work.
- Line blockages in use and the limits of those line blockages, do they cover your working area and give you a safe access and egress route.
- The controlling signal box is correct for the area you are working.
- Ensure any planned Site Visits are record and return them.

If something does not look right, then STOP. make sure you are in a safe place and ASK, then ESCALATE to the PICOP.



Japanese Knotweed & Great Crested Newts Safety Videos

**Japanese knotweed** is a fall, vigorous plant which has become one of the UK's most aggressive invasive species, establishing itself in both urban and rural settings.

#### What You Need to Know











- Location Awareness: Be alert during site inspections or works—report any sightings immediately as a
  Fault to Network Rail.
- Control Measures: Do not cut, dig, or move soil or plant material suspected to contain knotweed.



The **Great Crested Newt** is a Protected Species, meaning the animals, their eggs, breeding sites, and resting places are all protected by law. Offences can occur not only by harming the newts directly but also by disturbing or damaging their habitats.



Great Crested Newts are known to exist widely across the UK rail infrastructure, especially within 500 metres of a pond.



- Survey Early If a pond or suitable habitat is within 500m of the worksite, a newt survey must be considered during planning.
- Apply for a Licence This process can take several weeks and must be completed before works begin.
- Do Not Disturb Avoid working in or around water bodies or damp areas without environmental clearance.
- Report Suspected Habitat Always report in the 1st instance to the Bridgeway P.M. they will contact
  the client Ecologist, if the job is a Bridgeway job then report it to the P.M. and the B.C.L. O.C.M., giving as
  much detail as possible.

In recent months, there has been a notable increase in reports regarding the discovery of sharps and needles at access points and other locations within the railway infrastructure. Some of these items have been deliberately positioned in a manner that could potentially cause harm.







We ask all staff to remain vigilant and to maintain awareness of their surroundings at all times, with particular attention to access gates, location





















cabinets, doorways, and areas where drug use has been previously reported or is known to

As seen in the images above and below, the hazards appear to have been deliberately placed with the intent to cause harm to individuals using these locations. This presents a

serious risk of transmitting blood-borne diseases such as Hepatitis B, Hepatitis C, Syphilis, and HIV, among others.

If you find a Sharp / Needle

## Do Not Touch them or try to remove it. Report it Immediately

#### Safety Points to be aware of

- Never put yourself in danger, check your location for Sharps/Needles.
- Always wear the correct PPE: Gloves, Glasses, Head torch, Full Bridgeway PPE.
- Check Access gates Prior to unlocking gates, check padlocks and posts.

## Toolbox talk - Environment

### **Badgers**

#### What?

- □ badgers are a protected species
- □ both the animals and their setts are protected by law
- it is illegal to carry out any construction work close to a badger sett without taking steps to positively avoid damage and without an appropriate licence
- it is no excuse in law to be unaware of the presence of badgers.

#### Identification

- most badgers have the characteristic black and white striped face although very occasionally they can be creamy white (albino) or red/ginger in colour
- fully grown adults can be up to 1 m in length and weigh up to 14 kg
- the sett entrance is usually D-shaped and at around 300 mm wide by 200 mm high is wider than either a fox or rabbit hole
- there may be signs of freshly excavated material at the entrance or piles of leaves, dry grass, straw or bracken, which the badgers take inside to use as bedding
- badgers have a distinctive footprint five claws and a broad main pad
- an indicator of badgers can be found on trees or posts that badgers use for scratching.

#### Why?

- avoid prosecution: it is a criminal offence for anyone without a licence to:
  - kill, injure or handle a badger

#### Do

- IMMEDIATELY stop work and inform a line manager if a badger sett is found or a badger is seen on site or close to the site boundary
- seek guidance from a competent person before any work within 30 m of a badger sett.



- disturb a badger when it is occupying a sett
- interfere with a badger sett by damaging or destroying it
- obstruct the access to, or any entrance of, a badger sett
- breaking the law can lead to fines of up to £5000 per badger and/or up to six months in prison.

- x use heavy machines within 30 m
- use light machines within 20 m

carry out any works that are likely to disturb, damage or destroy a badger sett unless a line manager has categorically instructed to proceed further to a competent ecologists recommendation to do so.

#### Overview

Within the last week we've had two serious colleague injuries in Scotland.

The first event involved a security officer falling into an open inspection chamber causing serious injuries to their shoulder. The second event involved a maintenance colleague falling into a hidden culvert on third party land. Both events involved hidden hazards, and both could've been avoided.

In Scotland, slips, trips and falls are one of our main causes of injury amongst our colleagues.

Hazards like uncovered holes and uneven ground can be hard to spot until it's too late.

Poor lighting can prevent you from seeing potential dangers, making it difficult to tell where the ground starts or ends. Shadows may hide trip hazards, increasing the risk of accidents.

To stay safe, ensure all work areas are well scoped and well lit - if you can't see a hazard, you can't avoid it.

#### **Discussion Points**

- Always check the area before starting work.
- Always cover or clearly mark any openings or holes.
- Always make sure lighting is working – report it if it's not.
- Always use signs to warn others about risks.
- Never walk past a hazard without reporting it.
- Never leave a chamber or culvert open and unguarded.
- Never work in the dark or poor light without raising the issue.
- Never assume an area is safe just because it looks familiar.

#### Overview

On the night of 31st March 2025, at Greenhill Feeder Station Road Rail Access point (RRAP), a telehandler fitted with a bucket was used to load loose ballast onto a Road Rail vehicle (RRV) with no isolation of the Overhead Line Equipment (OLE) in place.

The telehandler was not authorised or equipped for Working Under Live (WUL) conditions, as it did not have a height limiter. Although the telehandler was sourced through the Plant Team, the request did not specify the need for WUL capability.

The Safe System of Work Pack (SWP) detailed that a WUL permit was in place; but that permit only covered the Nissan Navara and its trailer, not the telehandler that was used.

Both the Controller of Site Safety (COSS) and the Plant Operating Scheme (POS) Representative were aware that no OLE isolation was in place. However, they incorrectly believed the telehandler was authorised for Working Under Live conditions.

The telehandler operator did not raise any concerns, as they believed an isolation had been implemented.

This incident highlights a critical breakdown in planning, communication, and permit control. As a result, plant was operated under live OLE without the proper authorisation or safety controls in place.

#### **Discussion Points**

- Always be sure the required plans and permits are in place, before you start a job or go on or near the line.
- Always make sure you have authority to move or work under live.
- Always confirm that you have fully understood the briefing you are given.
- Never Work Under Live Overhead Line with unapproved machinery.
- Never assume the Overhead Line Equipment is isolated – always verify.
- Never ignore your concerns and if something doesn't feel safe use the Worksafe Procedure.

#### Relays containing Asbestos

#### Overview

BR930 relays manufactured prior to year 2000 have been found to contain Asbestos Containing Material (ACM) within the resin used to manufacture the base and or as part of the thermal element contained within the relay. Relays containing ACM must be boxed & labelled as containing asbestos during transportation & storage.

On a joint site visit between Network Rail & ORR to Dundee signalling Centre it was found that relays identified as containing ACM were being stored without the correct box & label.

#### **Underlying Causes**

Until the discovery of ACM within relay bases multiple relays were transported & stored in polystyrene/cardboard boxes, the relays were then removed from the polystyrene/cardboard boxes & stored on a shelf. Since the discovery of ACM within relays the transportation/storage of identified relays must be stored within individual boxes & labelled.

#### Key Message

- · Relays containing ACM must be boxed & labelled.
- Cracked or damaged relays should be disposed of in accordance with ACM waste regulations.
- Sites storing relays should be listed on Asbestos Management Plans
- Further guidance can be found in NB 224 Asbestos-containing materials (ACM's) in signal relays.
- Further advise can be sought from appointed Asbestos Responsible person in your business area.

- Information relayed poorly.

# Information must be clear and unambiguous - use locations:

- Signals.
- · Mileposts.
- Structures and other fixed railway assets.

Confirm understanding and be 100% certain you have reached a clear understanding - ask yourself:

- · Was it just repeated back parrot fashion?
- Was the information really understood?


#### Improving communications

- Avoid monotonous and unnecessary repeat back of information; think about what's being said and what it means.
- Allow sufficient time particularly at shift handover.
- Carefully specify what key information needs to be communicated - CONFIRM, CLARIFY AND REPEAT.
- Be assertive confidently saying what is needed whilst maintaining respect for others.
- Be clear.
- Be respectful and consider how you would like to be spoken to.

# Stay in Your Lane

You wouldn't walk out on to a motorway where vehicles are whizzing by, would you?

Wherever you are working, whether it's on the rail infrastructure, roads, highways or waterway, your safe work plan will specify the safe limits of your worksite or isolation. The limits are there to keep you safe. Near misses and other incidents involving workers are alarmingly common. It can happen when you lose situational awareness or don't have clarity on the arrangements or both. It can be entering the work area in the wrong location or straying beyond the safe limits of the

works area or isolation.

Before you start work, clearly identify the safe working limits. Use landmarks, structures, signals or mileposts to define the limits and if you are the COSS or Team Leader make sure everyone in the group is aware of the limits. Stay alert and be aware of what is happening around you. Continually check where you are and where you are supposed to be.

If you have ANY DOUBTS, get into a position of safety and refer to your safe system of work. Contact your PICOP, Team Leader, Supervisor or Bridgeway On-Call Manager if you need help

# **Autumn: Slips, Trips and Falls**

Slips, trips, and falls are one of the main causes of injuries in Autumn. Wet surfaces and equipment (e.g., Ladders, plant platforms) can be extremely slippery.

Leaves are one of the most significant fall hazards. When they accumulate, they can become slippery, especially when they are wet. Leaves can also conceal hazards, such as holes or debris, that can cause trips and falls.

#### Tips to reduce risks of injury:

- Ensure that your footwear is in good condition and the soles have good traction/grip.
- Do not put your hands in your pockets while walking.

- Remove wet leaves stuck to your footwear before working on ladders or plant platforms,
- Lace up your footwear properly this will help prevent unnecessary ankle injuries.
- Use sufficient lighting during darkness and poor visibility.
- Always use authorised walking routes and don't take short cuts.
- Watch where you are going and don't rush, especially when carrying equipment.
- Don't walk on sleepers or troughing.
- · Hold the handrail when using steps.

Even if you feel fine after you have slipped, tripped or fallen during work, you still need to report it on the Bridgeway Help App and to your Line Manager or the Bridgeway On-Call Manager.

#### **Autumn Season**

Knowing what species are active at this time of year can help us to protect wildlife, reduce disruption, and keep ourselves safe when working near the line.

- Swans, Geese and Ducks. Often found near rivers, canals and reservoirs by railway bridges. These birds may appear calm but can be highly protective of their young or nesting areas. Always keep your distance and avoid confrontation. Their presence near bridges can also increase droppings, which create slip hazards on walkways and platforms.
- Starlings. Famous for their evening "murmurations", when thousands fly in synchronised patterns around



viaducts, fields and stations. While spectacular to watch, large flocks can be noisy and leave significant droppings around railway structures.

Hedgehogs. Before hibernation, they travel further distances to find food and suitable nesting sites



hedgerows in and Always undergrowth. check vegetation before strimming or clearing, as they are small, well-camouflaged and vulnerable.

Badgers. Known for their powerful digging, they may burrow into embankments or under structures. Badger setts near bridges or culverts can undermine the ground, posing both ecological and engineering challenges.



- Wasps. Old nests are often found in bridge voids, signal bases and embankments. Even late in the season, wasps can be aggressive, particularly if nests are disturbed.
- Bats. It's is their last active feeding period before hibernation. Bridges, tunnels and culverts are common roosting sites. All bat species are protected under UK law, meaning their roosts must not be disturbed.
- Frogs, Toads and Newts. These species begin searching for hibernation sites under stones, logs, or in drainage systems. When working near culverts, always be mindful of their presence. Great crested newts, in particular, are a protected species.

#### **Key Reminders**

- Never disturb or handle wildlife; many species are legally protected.
- Be alert when working near vegetation, culverts, or water: these are prime habitats.

#### **Staying Vigilant**

Vigilance refers to the state of being alert and aware of your surroundings, enabling you to identify potential threats and respond appropriately. It is crucial not only for individuals in working in high-risk environments, such as working at height, on highways or the rail infrastructure, but also for everyday life.

Being vigilant helps you to recognise hazards, prevent accidents, and make informed decisions:

- Identifying Threats: Vigilance allows you to spot potential dangers early, whether in your personal life or while driving.
- Preventing Accidents: By being alert, you can avoid accidents and mishaps that may occur due to negligence or distraction.
- Enhancing Decision-Making: Quick and informed decisions can be made when you are aware of your surroundings, which is vital in emergencies.



#### **Practical Tips for Staying Vigilant**

- Be Aware of Your Surroundings: Always pay attention to what is happening around you. Be aware if you are working in a noisy environment, it can distract you from the task at hand and lower your vigilance.
  - Trust Your Instincts: If something feels off, trust your gut feeling. Don't hesitate to seek help or call authorities if you notice behaviour suspicious situations.
  - Communicate with Others: Share your concerns with those around you. More eyes and ears can enhance safety and help identify potential threats.
  - **Practice Situational Awareness:** Regularlyscanyourenvironment for exits, potential hazards, and unusual behaviour. This proactive approach help you respond quickly to emergencies.
  - Stay Prepared: Whether it's taking extra time to review safe work pack or knowing emergency contacts, being prepared can make a significant difference in critical situations.

#### **Drugs & Alcohol Testing**

Bridgeway supports Network Rail's zero tolerance approach to any drug and alcohol misuse. This is  $monitored\ with\ regular\ and\ random\ unannounced$ drug and alcohol testing:

- Random unannounced: No prior notification.
- Pre-placement: Pre-employment testing.
- Medicals: Periodic PTS Medicals.
- For cause: if there are grounds to suspect that an individual is unfit through drugs or alcohol.
- Post-incident: Following accidents or incidents.

As part of your drug and alcohol screening, you will be asked to provide a breath sample that will be tested for alcohol and a urine sample that will be tested for drugs.

If you are selected for drugs testing, you must give the tester details of any medication (prescribed or over the counter) you have taken, however trivial it may seem, or any injections or local anaesthetics you have been given, before the test is carried out as some medications may cause positive results in the drug tests. Refusal to undertake the test or leaving site when being selected will be treated as a positive outcome.

Any positive result can result in a 5-year ban from the railway. This will also be recorded onto Sentinel and will remain on there after your 5-year ban.

#### Working Safely With Others - Powertool Exclusion Zones by Guy Strickett, Enabling Works Principal Project Manager

There are many risks when working in the railway environment, many of which we are aware of and can mitigate in our own Safe Work Pack, Task Brief Sheet & Risk Assessment. However



working on the railway often leads us to have to work in the same area as other workers where dangerous jobs are taking place and extra risks exist that you may not be prepared for.

One of these risks is working on sites where vegetation cutting is taking place either as part of your work, to aid your work or as additional work in the same possession. It is important that you consider what additional risks may be present.

If it is a Bridgeway multi-team site all Person in Charge must take 5, complete a Point of Work Risk Assessment (POWRA) and brief each other/all staff regarding the work, risks and control measures/exclusion zones, all staff need to comply with these control measures.

Chainsaws, Strimmers/Brushcutters and Hedge Cutters are all dangerous tools and have risks associated with them if no control measures are put in place. These risks

include severe cuts, excessive noise and flying debris/ material. Control measures include PPE (Chainsaw helmets with face visors and ear defenders, chainsaw

trousers, chainsaw boots and gloves) these provide a last line of defence for the operatives however the best and safest control measure is an exclusion zone.





Safety exclusion zones are set up for everyone's safety, not to delay the work. On most occasions you would only an area for a few vegetation is cut start or complete your

While carrying out work on ECM2 1A, Jacob and the ISAR3 team came across a nesting pair of swans on the Downside — the mother swaddling her eggs while the male stood guard nearby. Recognising the importance of protecting local wildlife, Jacob immediately took responsible action.

The team kept a safe distance to avoid disturbing the birds and escalated the situation to management. As a result, the planned works were postponed until after the nesting season, ensuring the swans could remain undisturbed in their natural habitat.

This Close Call highlights the importance of staying alert not only to operational risks but also to our responsibility to protect wildlife. Jacob's actions prevented a potential disruption to a protected species and demonstrated excellent environmental awareness.

# **Autumn Driving Tips**

Autumn can be a very challenging time for drivers with shorter days, unpredictable weather and unique road hazards.

- Reduced Daylight: Shorter days mean more driving when visibility is lower. Use headlights at dawn, dusk, and in poor weather, even if it doesn't seem dark. Make sure headlights, brake lights, and indicators are clean and working properly.
- Fog and Glare: Reduce speed in fog and glare. Cooler mornings often bring fog, Use low-beam headlights when in fog. The low Autumn sun creates glare that can impair vision. Wear polarized sunglasses and keep the windscreen streak-free.
- Changing Weather: Sudden rain, early frost, or even the season's first snow can affect stopping distances and handling.
- Black Ice: Bridges and shaded roadways can freeze earlier than other surfaces. Stay Alert and drive cautiously on cold mornings and evenings.

- Wet Leaves: Fallen leaves can become as slippery as ice when wet, reducing traction and hiding potholes or lane markings. Keep extra space between your vehicle and the one ahead, especially on leaf-covered or damp roads. Braking distances increase significantly in these conditions.
- Wildlife Activity: Deer and other animals are more active during the fall, particularly around dawn and dusk. Slow down in rural areas, especially in early morning and evening. If an animal crosses, brake firmly, never swerve into oncoming traffic.
- Tyres and Wipers: Ensure tyres have adequate tread depth for wet conditions. Replace wiper blades if they streak or skip across the glass.

With increased traffic around schools, harvest activity, and variable weather, plan for longer journeys and build extra time into schedules to avoid rushing. Keep vehicles maintained to reduce the risks and ensure safe, reliable journeys throughout the season.

# Do you Have Bad Driving Habits?

# Are You Feeling Tired?

Driver fatigue refers to the state of feeling tired, drowsy, or exhausted while operating a vehicle. It is a ignificant hazard on the road as it impairs a driver's ability to stay alert, react quickly,

and make sound decisions, thus increasing the risk of accidents.

#### Did You Know?

- 83% of van drivers feel more tired in Autumn and
- 1 in 5 accidents are caused by tiredness.
- Peak times for fatigue-related crashes are within the hours of 02.00-06.00 and 14.00-16.00.
- Sleeping just 4-5 hours a night for a week impairs performance to the same extent as being legally over the alcohol limit.

Driving when tired or unwell impairs judgement and reaction time causing drivers to react slowly, brake late and is a major factor in a lot of rear end incidents. It also affects coordination resulting in a variance in speed - slowing down and speeding up. Tired drivers also have what is known as microsleeps, which last from a fraction of a second to 2 seconds. At 56mph a van travels 25m/sec, so microsleeping for 2 seconds means 50m of unconscious travel.

Motorways and dual carriageways are the most common roads for sleep related road incidents, due to the monotonous road environment and lack of interruptions. Crashes caused by drivers falling asleep involve vehicles running off the road or into the back of another vehicle. They tend to be high-speed impact incidents, and the risk of death or serious injury is high.
