Offering accountancy services to those contractors that find themselves outside IR35 and those higher earning inside IR35 contractors who still require a self-assessment.</p> <p><b>IR35 Support</b> – The IR35 status in most cases sits with the end hirer however for those working for small businesses who want an IR35 assessment we have partners in place who offer an insurance backed assessment.</p>
